## Nominations for the Office of Councillor

Public Notice is hereby given that nominations for the office of Councillor - One (1) to be elected for a term ending October 2026, will be received by the Chief Election Officer or Deputy Chief Election Officer from 9:00 a.m. on Tuesday, February 25, 2025, until 4:00 p.m. on Friday, March 7, 2025, as follows:

originals of emailed nomination documents must be received by the Chief Election Officer by 4:00 p.m. on Friday, March 14, 2025.

### QUALIFICATIONS FOR OFFICE

A person is qualified to be nominated, elected, and to hold office as a member of local government if they meet the following criteria:

- Canadian citizen; and
- 18 years of age or older on general voting day [April 12, 2025]; and
- resident of British Columbia for at least 6 months immediately before the day nomination papers are filed [September 6, 2024 or earlier]; and
- not disqualified under the *Local Government Act* or any other enactment from voting in an election in British Columbia or being nominated for, being elected to or holding the office, or be otherwise disqualified by law.

### CAMPAIGN PERIOD EXPENSE LIMITS

In accordance with the *Local Elections Campaign Financing Act*, for the 2025 by-election, the following expense limits for candidates during the campaign period apply:

- **Councillor:** \$5,398.92
